

COOKIE POLICY

We inform you that we use cookies to collect information about the use of this website in order to provide a better browsing experience and service.

What are cookies?

A cookie is a file downloaded to your computer, smartphone or other devices when you access certain web pages. Among other things, cookies allow a website to collect and recover information about the browsing behavior of the user or their device, and they can be used to recognize users.

What kind of cookies exists?

- Own and third-party cookies
- Own cookies: these are the cookies sent to the user's terminal from a device or domain managed by ECOMEDCIS S.A.S., from which the service is provided or from which the information requested by the user is provided.
- Third-party cookies: These are the cookies sent to the user's terminal from a domain other than the one they are visiting and which does not belong to us.
- Session cookies: these cookies are designed to collect and store data while the user is
 accessing a website. They are normally used to store information whose retention is
 only of interest for the provision of the service that the user requests on a single
 occasion. In the long term, these cookies can be used to provide a better experience by
 improving content and facilitating use.
- Permanent cookies: with these cookies, the data is stored on the terminal device and it
 is possible to access and process it for a period of time set by the responsible provider
 for the cookies.
- Purpose of the cookies
 - Strictly necessary cookies: These cookies allow the user to browse areas with usage restrictions and use their different functions. We use these cookies on the basis of our legitimate interest to allow the website to function properly.
 - ii. Performance cookies: These cookies allow us to count visits and traffic sources so we can measure and improve the performance of our site. They help us to know which pages are the most and least popular and see how visitors move around the site
 - iii. Functional cookies: These cookies enable the website to provide enhanced functionality and personalization. They may be set by us or by third-party providers whose services we have added to our pages. If you do not allow these cookies then some or all of these services may not function properly.
 - iv. Advertising cookies: These cookies are used to track our visitors' browsing habits. They can be used to build up a profile of search and/or browsing history



for every visitor. Identifiable or unique data is collected to show relevant/personalized marketing content to each user. The information that uniquely identifies users' browsers and internet devices is used to display targeted advertising and/or share this data with third parties for the same purpose.

The processing of strictly necessary cookies is based on the legitimate interest of ECOMEDICS S.A.S. for the purposes explained below. Performance cookies, functional cookies or targeting cookies are processed on users' consent for the purposes explained below. Users' consent is collected and registered following the selection of cookie preferences in our cookie banner.

Google Analytics

Google Re-Captcha



We use Google's reCAPTCHA service to determine whether a person or a computer enters information in our contact form.
